At its 36th session, in 1981, the United Nations General Assembly, recalling that the promotion of peace, both at the international and the national level, is among the main purposes of the United Nations, in conformity with its Charter, decided that it would be appropriate "to devote a specific time to concentrate the efforts of the United Nations and its Member States, as well as of the whole of mankind, to promoting the ideals of peace and to giving positive evidence of their commitment to peace in all viable ways".

The Assembly therefore declared, in a resolution adopted on 30 November 1981, that the third Tuesday in September, the opening day of its regular annual session, should be officially dedicated and observed as the *International Day of Peace* and should be devoted "to commemorating and strengthening the ideals of peace both within and among all nations and peoples". It invited all Member States, organs and organizations of the United Nations system, regional organizations, non-governmental organizations, peoples and individuals "to commemorate in an appropriate manner the International Day of Peace, especially through all means of education", and to co-operate with the United Nations in the observance of the Day.

The Assembly recalled that—as set forth in the Charter of UNESCO—"since wars begin in the minds of men, it is in the minds of men that the defence of peace must be constructed" and that "peace must therefore be founded, if it is not to fail, upon the intellectual and moral solidarity of mankind".

The Assembly's resolution was initiated by the representative of Costa Rica, who declared that the International Day of Peace "will serve as a reminder to all peoples that our Organization, with all its limitations, is a living instrument in the service of peace and should serve all of us here within the Organization as a constantly pealing bell reminding us that our permanent commitment, above all interests or differences of any kind, is to peace. May this peace day indeed be a day of peace".

The first International Day of Peace was observed at United Nations
Headquarters in New York on 21 September 1982, the opening day of the
37th session of the General Assembly. At the start of the session, delegates
stood for the traditional minute of silence in observance of the Day.

Messages for the International Day of Peace were issued by the Secretary-General, Javier Pérez de Cuéllar; the President of the Security Council, Masahiro Nisibori (Japan); and the President of the General Assembly, Imre Hollai (Hungary). A message from 69 non-governmental organizations, issued on the occasion of the International Day of Peace, was sent to the President of the Assembly. The texts of these messages are reproduced on the following pages.

The International Day of Peace was also observed in many countries around the world and by the organizations of the United Nations system. At a special ceremony at Unesco House in Paris, the UNESCO Prize for Peace Education was awarded to the Stockholm International Peace Research Institute. In Vienna, headquarters of the International Atomic Energy Agency, an exhibit was mounted depicting 25 years of IAEA activities for the peaceful applications of nuclear energy.

2. The TEMPORARY PRESIDENT: As we observe minute of silence in accordance with rule 62 of the rules of procedure, may we also on this occasion observe the International Day of Peace, proclaimed by the General Assembly in its resolution 36/67 of November 1981, to be devoted to commemorating and strengthening the ideals of peace both within and among all nations and peoples. In doing so, lowever, I must recall, as I pointed out yesterday when I closed the thirty-sixth session, that it is selfevident that the world is not at peace—far from it. Conflicts persist in all parts of the globe. But perhaps uppermost in our minds at this moment is the horrible spectre of the hundreds of men, women and children slaughtered in the terrible massacres at the Palestinian refugee camps in Beirut. I feel sure, as we rise to observe the traditional minute of silent prayer or meditation, that on behalf of all of you I am conveying the sense of deep outrage felt by the entire international community and transmit to the families of the innocent victims our profound sense of sorrow and dismay.

3. I now invite representatives to stand and observe one minute of silent prayer or meditation.

Mr. Imre Hollai (Hungary) was elected by acclamation President of the General Assembly (decision 37/302).

9. The TEMPORARY PRESIDENT: May I be the first to extend my sincerest congratulations to Mr. Imre Hollai on his election and I invite him to assume the presidency.
